

# The State of Deep

Any and nearly everybody reading news in English lately is familiar with the phrase *Deep State*; in fact, it's been used here several times. In the wake of the attempt to assassinate Trump, the term has gained new momentum from what little news I've seen. I haven't looked at more because it seems like standing behind a large, well-fed bull with a permanent case of diarrhea. Not continuous but ongoing. Avoidance works better than a box of Imodium when it comes to news, its analysis and related press opinion.

I ask The Committee for their observations.

*Q: You have told us the shooter did not act alone, which is easy to see. How a 20-year young man with little life experience, street smarts or marksmanship skill could take his father's rifle, a rangefinder and a ladder bought from a hardware store, then defeat local police (Butler County Emergency Services) plus the Pennsylvania State Police and the United States Secret Service, is hard to digest.*

*C: Had the attempt been successful, the goal would have been achieved. The shooter would never escape death or evade justice if caught, which was almost certain. He was identified, indoctrinated, groomed and taught what to do, his owners knowing the shooter was to be thrown away, which is what happened. The shooter's silence would be assured in either outcome, his death or apprehension, blocking any route to handlers who prepared him emotionally and psychologically. The risk the shooter would speak if he survived, would not matter. His statements would be framed as evidence of a deranged, crazy thus entirely unbelievable person. The target would be dead, the only apparent actor solely responsible. Had the shooter's lawyers, if he were apprehended, convinced him to remain quiet, an easy thing to achieve, this would be the same as the shooter's death. It would be determined that he acted alone.*

*Q: The ultimate decision makers are frustrated with the failure, obviously. Why didn't they ensure success, e.g. JFK style from Dallas, Texas in 1963?*

*C: This would have been too difficult to do and cover-up, both; it would have been impossible to corrupt enough law enforcement, security personnel and investigators not to look away from incoming rifle shots from different directions.*

*Q: Are the ultimate decision makers going to try again before the election in November or inauguration in January, if Trump wins the election?*

*C: This decision is being considered but has not yet been made. Other than rifles, many methods remain available, such as bombs, poisons or missiles, among others. The risk is the effect on the voting citizens of the USA; will the death of Donald Trump not result in social disturbances such as violent protests, riots, civil commotion in general? Concealing the process behind the assassination is relatively easy when compared to the aftermath of effects; this has been and is done with some regularity; your reference to the assassination of USA President*

John F. Kennedy more than six decades ago is an example.

Social disturbances will undermine the goals of the HCPs, who have also considered how the first presidency of Donald Trump was tolerated and survived. The HCPs see his second term in office as better, if still undesirable, than widespread disbelief and erosion of faith in national security and integrity.

*Q: Often repeated is the idea Trump is a threat to Democracy in the USA but Biden's exit from the campaign for re-election seems more like that; didn't many tens of millions of voters select him as the Democrat candidate? We can see how rejecting the collective decision of voters turns away from democracy, not towards it, but what is going on?*

C: Mr. Biden was told —ordered is a correct word for it— to quit his candidacy and to endorse the current USA Vice President. Mr. Biden's public silence and travel to a personal residence away from the USA's capitol for a few recent days after the announcement, was also instructed, to prevent access to him, to allow a cooling down and to permit attention be focused on his endorsement of the Vice President.

*Q: Biden did not choose her in the first place, so being told to support her now seems easy for him to do.*

C: Mr. Biden did not object or care much about the second part of the orders he received. He is disappointed and frustrated that he is being sent away, because he does not perceive the decline in his mental capacity in the same ways observers can.

*Q: Introducing the head of the Ukrainian Government as President Putin? Referring to Kamala Harris as Vice President Trump?*

C: Mr. Putin is the true head of the Ukrainian government, so Mr. Biden was not wrong, but he let slip what he already understands. He knows this was a mistake but considers it only inconvenient. The challenge the HCPs face is that Mr. Biden is in position to let slip many other things; it is impossible to install a puppet leader without allowing such marionette some knowledge and access to certain information and authorities. This is necessary to maintain the image of government USA citizens and many others around the world expect.

He was thinking of Trump when required to introduce the USA Vice President, which is the reason he mixed them up. It is considered far too risky to allow him another slip.

*Q: Did the HCPs believe Biden's decline could drop slowly enough over eight years, when he was ordered out of retirement to run for The White House in the 2020 election?*

C: This was unknown, as the rate of mental decline cannot be forecast. The evaluation at the time, was that Mr. Biden's mental ability would not decline far or fast enough over these 3 and  $\frac{2}{3}$  years to prevent a good masquerade, which has been achieved until recently.

*Q: You mean the presidential debate?*

C: Yes. This was impossible to manipulate; the HCPs hoped that Mr. Trump would revert to a bombastic approach, but as observers noted, did not occur. Mr. Biden's several attempts to

provoke Mr. Trump into crude retort were unsuccessful.

*Q: What about the Democrat elected officials from the House of Representatives, the Senate and others such as few governors I think (I might be wrong on the governor part) who led the charge to have Biden quit his re-election campaign? Were they all corrupted by the HCPs?*

C: Not all but only a few; the majority did what holders of public office routinely do; this was predictable. They sought to separate themselves from the losing horse, to maintain their position. The HCPs took advantage of this predictability to allow the image to form of a political party coup d'état, which has happened. The majority of calls for Mr. Biden's exit from the race occurred organically. This is expected politician behavior.

*Q: Was the timing of the assassination attempt set because of the imminent Republican National Convention?*

C: Yes.

*Q: Are there other would-be assassins still out & about, who have been identified as vulnerable, then groomed and indoctrinated as was young Mr. Crooks?*

C: Yes, but the immediate death of Mr. Crooks has all but eliminated that method, for the remainder of the campaign.

*Q: Why was Donald Trump not taken out in 2016?*

C: His victory was not foreseen. The HCPs and others in a position to do that, pursued other means but did not believe Mr. Trump could prevail.

*Q: Other than the means employed to remove him, such as to float the fantasy that Donald Trump was owned and controlled by Russia and Vladimir Putin, what else was done to throttle Mr. Trump from January of 2017 until the same month of 2021?*

C: The HCPs used the standard behind-the-scenes techniques, which have been successfully used to control USA Presidents since 1964. These did not work; Mr. Trump rebuffed them and even dared them to act, knowing that the American citizens would not believe any story offered as to how Mr. Trump was taken out of office.

*Q: When we hear Deep State, what does or might this mean?*

C: This is not the cohort of HCPs, we assure you. You our medium host have given us a nickname; humans nearly always require a label for something perceived to exist. As an example, we refer to the books and to the movies made from them, about Harry Potter. The villain's name is both suppressed openly but also quietly whispered between people aware of him. This is an example of the human perception requirement, in the case of the books and movies, that Voldemort cannot exist unless identified by a name. Human acronyms result from this same requirement, when the name becomes a challenge to always say at length or write out.

The Deep State refers to the HCP assets who are not elected but involved with governance and authority.

You have given the HCPs a nickname, for this same purpose and effect, but in practice neither this label or other name is ever used. Vocubular invisibility thus anonymity are the best insulation and protection. The unseen target is all but impossible to strike.

*Q: The widespread belief is that the Deep State is bad, if for nothing else because it is not transparent. How do humans eliminate this effect?*

C: Humans can achieve this by lessening the creation of central authorities, and this means shrinking governments. This is achieved by giving less energy to government and simultaneously expecting less. This is the only assured means, guaranteed method or surefire way, to reduce or eventually eliminate a Deep State.

*Q: Is there no way on Earth for humans to reduce the human proclivity to seek and exercise authority?*

C: Many ways exist for this but are not practiced at larger and larger levels. Authority within a family or a small, voluntarily formed group requires it for the unit to be successful as the great surrounding society defines success.

Human emphasis on wealth and acquisition power, known as money, is only one side of the coin. Humans must also produce the thing the money might obtain. Too often this is taken for granted because it seems automatic, to rich and poor alike of every level, that money will sooner or later, and usually sooner, prompt the delivery of goods and services. In turn many of the goods and services are offered mostly or solely for the money.

Money is a human creation. Control over it is learned behavior. Had the migrant settlers of western USA lands been able to suspend or freeze Indian indigenous bank accounts in the early and mid-19<sup>th</sup> century, we can assure you, this would have been done.

Transparency can be easily taught among humans, because it is the natural condition of all souls in Heaven. It is not a widespread practice on Earth; concealment provides a temporary mental refuge for humans and is one aspect of spiritual purpose all souls seek to experience.

Where is any business, corporation or commercial venture successful among Earth humans by publishing the prices it pays and charges to suppliers and customers, item by item? Does any business large or small disclose all salaries and bonuses paid to employees? *Q: Donald Trump vowed to get rid of the Deep State and no doubt, we'll hear more of this political bluster over the next few months. Mr. Trump must understand what is really going on.*

C: Mr. Trump is doing what all leaders must, identify a villain then rally resistance. Hitler used Jews; many examples exist in human history. To call out the partisan press or the deep state part of government —both were and remain effective villain targets— because the

evidence supporting their existence is not scant. Mr. Trump's was an effective strategy and will continue to be for him.
